The surgery is in purpose built premises and has on-site car parking available for patients and staff.

Parkside Surgery is also a training practice with GP registrars from Derby and Chesterfield. We also accommodated medical students from Nottingham and Derby.

The registered activities under CQC are:

- Routine medical checks and general medical services.
- NHS relevant prescriptions and medications or a private prescription can be issued.
- Vaccinations and immunisations the practice strongly supports the
  childhood immunisation programme. All routine childhood vaccinations are
  performed at the surgery by one of our practice nurses. We also offer all 'at
  risk' patients the seasonal influenza vaccination from September to March
  every year.
- NHS Foreign travel immunisation NHS vaccinations only provided by our practice nurses
- Medicals the GP's carry out medical reports and examinations
- Chronic disease management this encompasses a wide range of conditions which require long term treatment and care. Our priority is to ensure this care is on-going and appropriate and we endeavour to review patients medication on an annual basis. Spirometry testing is also available.
- Family planning and contraceptive services this is provided by the doctors and nurses.
- **Phlebotomy** patients can be seen at clinics in the Primary Care Health Centre or Ripley Hospital.
- **Maternity services** The community midwife holds a weekly clinic at the primary care centre on a Wednesday and Friday. The doctors also provide ante-natal and post-natal care.
- **Minor Surgery** appointments available for some dermatology related conditions.
- Ear syringing facilities available for ear syringing when staffing allows
- Well person checks these are carried out by our Health Care Assistant.
- **ECG monitoring** the surgery is able to offer in house ECGs.
- Cervical screening this service is provided by our trained practice nurses.

Our practice ethos is to strive towards a partnership between patients and healthcare professionals based on the following:

We endeavour to treat all our patients with dignity, respect and honesty. Everyone at the surgery is committed to providing excellent patient care.

#### **Continuity of Care**

Continuity for all patients is promoted through regular internal meetings and communications.

### **Learning and Training**

The practice is a training practice and we are committed to the training of doctors and nurses, who are all closely supervised. We recognise the vital role students have in keeping the practice fresh and reflective. All staff within the practice have an annual appraisal where their training needs are identified. We also recognise the benefit of supported learning for patients to enhance the ability to self-manage and deal with long term conditions.
